New Plan Effective January 1, 2026

Key Points

- As Reported by the Municipal Labor Committee:
 - The City of New York and the Municipal Labor Committee (MLC) have agreed to replace the current GHI-CBP Plan with a new health Plan effective 1/1/2026 for active NYC employees and pre-Medicare retirees.
 - The new plan will be called the NCYE PPO and will be administered by Emblem Health and United Healthcare.
 - NYCE PPO will be a \$0 premium option for at least 5 years.
 - Emblem Health will manage the network in the 13 Downstate Counties of New York (DS13).
 - United Healthcare will manage the network outside of the DS13.

NYCE PPO Plan Highlights

- As Reported by The Municipal Labor Committee:
 - NYCE PPO will replace GHI-CBP effective 1/1/2025.
 - All GHI-CBP benefits will continue.
 - Copayments/Deductibles will not increase.
 - Network size will increase in NYC-Metro and Nationally.
 - Fewer Prior-Authorizations will be required.
 - Members will receive a single ID card.

NYCE PPO Network

Downstate 13:

- Emblem Health Network.
- Includes the 5 major hospital systems.
- Centers of Excellence Program (HSS/MSK) will be preserved.
- Approximately 14,000 more providers compared to GHI-CBP.

Outside DS13:

- United Healthcare Network.
- Approximately 1.6M providers nation-wide (compare to the current 29,000).
- Out-of-State pre-Medicare retirees will have far greater access to innetwork care.

NYCE PPO Prescription Drug Coverage

- NYCE PPO will provide coverage for the same drug categories currently covered by GHI-CBP:
 - Diabetes
 - ACA Preventive Drugs (Including low dose statins).
- The PBA Prescription Drug Plan is unchanged.
- The PICA Program is not changing on 1/1/2026, but is subject to RFP in 2026.
- The LOD Prescription Drug Program will remain unchanged.

Transition to NYCE PPO

- Current GHI-CBP Members:
 - You will automatically be transferred to NYCE PPO on 1/1/226.
 - You may transfer to another NYC Health Plan during the Annual Transfer Period in November.
- Members in other NYC Health Plans:
 - You will remain in your current health plan unless you transfer to NYCE PPO (or a different plan) during the Annual Transfer Period in November.
